

PRIVACY NOTICE

In accordance with the provisions of the Mexican Federal Law for the Protection of Personal Information in the Possession of Individuals and its Regulations (hereinafter referred to as the "Law"), PARTIDA Y RUIZ LEGAL, S.C. issues the following Privacy Notice:

1. IDENTITY, ADDRESS AND COMMITMENT OF THE RESPONSIBLE PARTY:

Partida y Ruiz Legal, S.C. (hereinafter "P&R LEGAL"), with registered offices at Avenida Américas 1545, 20th floor, Colonia Providencia, Guadalajara, Jalisco, Mexico. Z.C. 44630, telephone number: (33) 8000-0024, website: www.prlegal.mx, email: info@prlegal.mx, is responsible, under the terms of the Law, for the collection, disclosure, storage, use, handling and transfer of personal information collected from any identifiable person.

P&R LEGAL undertakes to handle the personal information provided with the utmost confidentiality in accordance with the applicable legal provisions and principles relating to the protection of personal information.

2. PERSONAL DATA TO BE PROCESSED.

P&R LEGAL may obtain personal information directly from You, either personally or through electronic channels and/or postal correspondence. In some cases, P&R LEGAL may also obtain such data indirectly through third parties or other sources.

The personal information that P&R LEGAL may obtain and use includes, but is not limited to: your full name, telephone number, e-mail address, address, place of work, photograph, signature, ID card, passport and visa information, nationality, immigration status, RFC, CURP, job title, account information, marital status, credit record, and tax and corporate information.

Similarly, there is the possibility that it may be necessary to collect some sensitive information: bank statements, information about your financial situation, and private information regarding your family or health situation, which will happen only and exclusively when strictly necessary for the proper provision of our services to You.

3. PURPOSE OF DATA PROCESSING.

The sole purpose of obtaining and processing your personal information will be to adequately provide our services for your benefit. Your personal information will be collected in order to have a real and complete knowledge of your legal situation, and to have always present all the relevant elements to execute an adequate defense of your interests.

Your personal information will only be used in procedures strictly related to the rendering of our services, so that our Firm can: correctly elaborate all legal documents on your behalf, service proposals, legal opinions, payments, administrative procedures, file legal appeals and deliver notifications. Your personal information will also be used to maintain a direct and effective communication with You through telephone calls, e-mails and traditional postal correspondence.

4. TRANSFER OF PERSONAL INFORMATION.

As a general rule, your personal information will not be transferred to any other person or entity, and will remain safeguarded in our database. However, there is a possibility that

some of your personal information may be transferred to third parties who also provide accounting and/or legal services to P&R LEGAL. Should such a transfer occur, P&R LEGAL shall communicate this privacy notice to such third parties, who shall abide by it.

5. ADDITIONAL METHODS TO LIMIT THE USE OR DISCLOSURE OF YOUR PERSONAL INFORMATION.

In order that You may limit the use and disclosure of your personal information, we inform you that, in addition to the security measures that P&R LEGAL has, you have at your disposal the registration in the Public Registry to Avoid Advertising that is in charge of the Mexican Consumer Protection Agency (PROFECO) in order that your information is not used to receive advertising or promotions of goods or services companies. For more information about this Registry, you can consult PROFECO's website or contact them.

As far as P&R LEGAL is concerned, you may at any time exercise your ARCO Rights to limit P&R LEGAL's use of your personal information in strict compliance with this privacy notice.

6. PROCEDURE FOR ACCESSING, RECTIFYING, CANCELLING OR OPPOSING THE USE OF YOUR PERSONAL INFORMATION (ARCO RIGHTS).

At any time, You may Access, Rectify, Cancel or Oppose the consent given to P&R LEGAL for the processing and use of your personal information. To do so, You must submit a written request to the following e-mail address: info@prlegal.mx.

The ARCO request must include the following information: i) your full name; ii) if applicable, name or company name; iii) e-mail address; iv) telephone number; v) personal information about which you wish to access, rectify, cancel or oppose, and; vi) the reason for your ARCO request. P&R LEGAL shall have a term of fifteen working days to respond to your request.

If you have requested access to your personal information, P&R LEGAL shall provide you with a simple copy of the data at its disposal, which copy may be sent by electronic means or traditional postal correspondence within the period described in the preceding paragraph.

7. REVOCATION OF CONSENT.

At any time, You may revoke the consent given to P&R LEGAL for the processing of your personal information, so as to stop using it. To do so, you must submit a request in the terms mentioned for the exercise of ARCO rights, following the same procedure.

8. USE OF COOKIES, WEB BEACONS AND OTHER TECHNOLOGIES.

Websites or Internet sites often require the use of encrypted or non-encrypted cookies. Cookies are data that a web server transfers to your computer for record-keeping purposes. Cookies are commonly used in the industry by virtually all web or internet sites and make it easier for you to access and use specific sites or specific web pages by providing information that can be used to deliver specific content tailored to your interests and for other purposes such as security and other account management functions, which may result in the tracking of personally identifiable information.

Cookies do not harm your computer and only the website or web page that transfers them can read, modify or delete them. If you do not want any information collected through

cookies, most browsers have simple systems that allow you to delete them, automatically reject them, or allow you to choose whether or not to accept the transfer of cookies to your computer. Please refer to your browser instructions or browser's help screen for more information about these functions. You should note, however, that if you do not accept cookies it may be difficult or impossible to access certain parts of websites or Internet pages, including that of P&R LEGAL (www.prlegal.mx).

P&R LEGAL's web page or web site may make use of tools known as "clear pixels", "web crawlers" or "clear gifs" (hereinafter collectively referred to as "clear pixels") to compile statistics on web page or web site usage and response rates. Clear pixels allow us to count users who have visited the website or web page, provide corporate services and help determine the effectiveness of promotional campaigns. If HTML e-mail messages are used, the transparent pixels can inform the sender when the message has been opened.

P&R LEGAL also collects information about "referrers" (this is information that your web browser transmits to our web server that refers to the URL from which you access P&R LEGAL's web site or web page), "IP addresses" (this is a number used by computers on a network to identify the computer in question so that information can be transmitted to it) and various "environment variables" (these are, among other things, the domain from which you access the Internet, the time you access the site, the type of Web browser, operating system or platform you use, the Internet or Web site address that referred you to this site, the names of the pages of the site you visit, and the Internet address of the Web site or Web page you visit next).

This information is collected for P&R LEGAL's internal use, for example, to enhance the security of the website or web page, to detect important demographic trends, to help P&R LEGAL deliver content that best matches your interests, and to otherwise enhance your experience on the website or web page. Information may also be shared with third parties on a general level, without including your identifying information.

9. AMENDMENTS TO THE PRIVACY NOTICE.

Any modification to this privacy notice or to the purposes of the processing of the personal information You have provided to us will be notified to you by e-mail and/or telephone call and/or in person. Likewise, such changes will be published on P&R LEGAL's website (www.prlegal.mx).
